Old Business

Update on front entrance construction process

Doug Gibbs, the Project manager, noted that there were very likely going to be some decisions come up as the project moves forward that will need the Boards approval. In order that these decisions can be made timely, and not have to wait for a scheduled Board meeting, the Board will handle these via email as they arise. Retained emails will document the Board's decisions.

Regarding the submission to Larimer County of our application for a building permit, the County said that the height of our sign does not meet County guidelines. Doug to meet with county official to discuss since in all previous discussions with the County when they were shown the actual plans, the sign height was never mentioned as an issue.

The Board expressed it's appreciation for the timely and informative updates that Doug has regularly sent to the Board. These updates will be condensed and

included in the minutes from here forward.

New Business

The treasurer requested that the Board consider raising the General Reserve Fund to \$5000 as opposed to it's current limit of \$2000. As an example, without a budget surplus, the pending bill from Century Link (which could be \$3000 to \$4000 depending on negotiations) could not be covered by the existing limit and would necessitate moving money from one of the other Reserve accounts. However, because of our Operating Procedures, money can not be moved from one Reserve Account to another without approval of the membership. Recognizing that the intent of the Operating Procedure is to limit the discretion of the Board, it was still felt that the current limit in today's economy is too low. Therefore the Board voted to increase the General Reserve to \$5000. Filling the General Reserve to the new limit will commence in 2024 and will be shared 50/50 with bolstering the Equipment reserve.

Final planning for the December landowner meeting.

Tom presented the proposed budget to 2024, showing no increase for 2024. Because of some ongoing cost savings such as the reduced dumpster fees, this budget includes an increase for the road crew from the current \$30/hr to \$35/hr. The proposed budget will be sent to the members prior to the winter meeting.
